## WDN On-Reserve 50/50 Home Improvement Program April 1, 2025 – March 31, 2026

### Program:

- Provides financial assistance to Whitecap Dakota Nation (WDN) members of an amount equal to 50% of total costs of home improvement projects of existing homes on-reserve for total renovation projects up to a maximum of \$10,000 contribution (less the WCIF) by WDN.
- Funds are based on 'first-come, first-served' and project requests will be approved based on available budget.
- One application per project per band member per fiscal year.
- Members must pre-pay their 50% of the project.

### Eligibility:

- Applicant must be a contracted tenant residing in a WDN unit or legally registered owner of a unit on Whitecap Dakota lands.
- Applicant must be in good financial standing with the WDN.
- Applicants must confirm they have the resources or required loan or mortgage for their 50% share of the estimated project.
- Project plans must comply with all WDN permit and building processes, Environmental Site Assessment, National Building Code, zoning and development standards and the *Whitecap Dakota Nation Land Code*.

### Approval Process:

- All qualifying Band Members must complete an application form and submit it to the Chief Executive Officer (CEO).
- All projects must be pre-approved by the CEO in consultation with the WDN Council.
- Final inspection will be carried out by the Director, Housing including confirmation of actual costs.
- Contractor needs to be pre-approved by WDN.
