# WDN On-Reserve Private Home Ownership Program

April 1, 2025 - March 31, 2026

#### Program:

 Provides financial assistance to Whitecap Dakota Nation (WDN) members for private home ownership on-reserve.

#### Assistance:

- A one-time grant of \$25,000.
- A one-time grant for the land value of a legally surveyed 99-year residential leasehold interest as per the *Whitecap Dakota First Land Code*.
- In the event a financial institution requires a member to incorporate to address the financial
  institution's concerns about section 89 of the *Indian Act*, (the restriction on seizing a status
  Indian's property on-reserve) the WDN will provide additional resources of up to \$1,000 for
  corporate legal fees.
- Upon receipt of pre-approved mortgage documents, payment will be made directly to the financial institution.

#### **Eligibility:**

- Applicant must be a WDN Band Member.
- Applicant must qualify for a preapproved mortgage with a financial institution.
- Applicant may be required to incorporate a non-profit entity to hold 99-year residential leasehold interest title and the mortgage.
- Home must be built on approved legally surveyed and serviced lot.
- Building plans must comply with all WDN permit and building processes, Environmental Site Assessment, National Building Code, zoning and development standards and the Whitecap Dakota Nation Land Code.

#### **Approval Process:**

- All qualifying Band Members must complete an application form and submit it to the Director, Housing.
- Application will be reviewed in consultation with the WDN Council.
