WDFN On-Reserve Private Home Ownership Program

April 1, 2023 - March 31, 2024

Program:

 Provides financial assistance to Whitecap Dakota First Nation members for private home ownership on-reserve.

Assistance:

- A one-time grant of \$25,000.
- A one-time grant for the land value of a legally surveyed 99-year residential leasehold interest as per the *Whitecap Dakota First Nation Land Code*.
- In the event a financial institution requires a member to incorporate to address the financial institution's concerns about section 89 of the *Indian Act*, (the restriction on seizing a status Indian's property on-reserve) the First Nation will provide additional resources of up to \$1,000 for corporate legal fees.
- Upon receipt of pre-approved mortgage documents, payment will be made directly to the financial institution.

Eligibility:

- Applicant must be a Whitecap Dakota First Nation (WDFN) Member.
- Applicant must qualify for a preapproved mortgage with a financial institution.
- Applicant may be required to incorporate a non-profit entity to hold 99-year residential leasehold interest title and the mortgage.
- Home must be built on approved legally surveyed and serviced lot.
- Building plans must comply with all WDFN permit and building processes, Environmental Site Assessment, National Building Code, zoning and development standards and the Whitecap Dakota First Nation Land Code.

Approval Process:

- All qualifying Band Members must complete an application form and submit to the Director, Housing and Public Works.
- Application will be reviewed in consultation with Chief and Council.
